Cabinet has now approved funding to progress the replacement of our fleet with electric vehicles, in line with our 2030 [climate action framework](#).

This funding will be used to buy vehicles centrally, which will then be recharged to department on a monthly basis. This allows a lot more flexibility and enables us to get the best value from it.

People Scrutiny: Currently leading a group looking at SEND specific issues, speaking to parents, educators and service providers, currently we are in interviewing stages.
